

Faculty and Students of Jain Vidya Prasarak Mandal'S College of Education, Chinchwad Pune

Terms of the MOU

GENERAL REGULATIONS. ELIGIBILITY AND ENROLMENT

1. The two parties agree to enter into a student exchange agreement, commencing in the academic year 2017-2022.
2. The participating students and faculty will register at the host institution for the full academic year or for a minimum of one academic term.
3. Each institution may send up to 05 students and 02 faculty per academic year to participate in the exchange. The number of participants may be increased subject to the mutual agreement of both institutes.
4. It is expected that in any given year there will be an equal number of students exchange from each institution. The numbers of faculty also equal for the faculty exchange program.
5. Notwithstanding Clauses 3 and 4 above, while equal number in every year may not be possible, efforts will be made to have equal number exchanged over a five-year period.
6. The participant will be students who are completing an undergraduate program or graduate program at their respective institutions.
7. The participants will be selected by their respective institutions to participate in the exchange. Candidates must satisfy admission requirements for special students status, including language proficiency requirements, of the host institution or the host department.
8. Participants in the faculty exchange will be required to have completed at least one year of teaching experience prior to participation in the exchange. Participating graduate students should have completed at least one term of studies at the homes institutes.
9. Each institution will appoint an individual to act as the coordinator for the exchange. The exchange is coordinated in both institutes through coordinator.

10. The host institution will have the right of refusal of any candidate who may appear to be unacceptable for the exchange.

FINANCIAL ARRANGEMENTS

11. The home institution will pay the travelling allowance for the respective faculty- students exchange program at the home institution to travelling for the host institution for.
12. The attendance of students is compulsory for every session.

RESOURCES AND REGULATIONS AT THE HOST INSTITUTION

13. The topic as per the curriculum and class and time-table for the faculty and student exchange program will be decided by the host institute by making coordination with other institution.
14. At the end of the academic year, the participants in the exchange will request the host institution to send to the home institution a report/official transcript of their academic achievement.
15. Each participant in the exchange must ensure that they have adequate health and accident insurance coverage.
16. Exchange students are subject to the rules and regulations of the host institution. The host institution reserves the right to dismiss any participating students at any time for academic or personal misconduct. The dismissal of a participant shall not abrogate the agreement for the arrangements regarding other participants.

DURATION, AMENDMENT AND TREMINATION OF THIS AGREEMENT

17. The parties will review the terms of the MOU annually to success of the exchange, and will determine whether to continue, modify or discontinue the MOU. Each party reserves the right to terminate this MOU upon six months written notice to the other. Any exchanges of students taking place at the time of termination will not be affected; exchange students who already stay at the host institution will be allowed to complete the exchange program.
18. This MOU shall take effect when signed by both parties, and will remain in effect for a period of five years. Thereafter, it has to be renewed for another period.

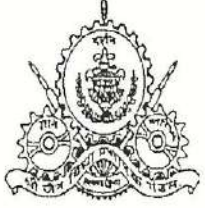
